Financial Terms and Conditions

Acceptance of Liability

On signing this document, the Parents/Stepparents/Guardians (hereafter referred to as “the responsible persons”) assume liability for the account and for payment of all school fees and expenses to Accelerated Academy (hereafter referred to as “the School”).

Terms of Payment

School fees are determined at the beginning of the year and are communicated to the responsible persons in writing. Invoices are sent out with the students on a monthly basis. The responsible person shall immediately inform the school if he has not received an invoice. School fees are calculated over **12 months** and are payable monthly **in advance**. Should a student not return in the following year, notice should be given at the beginning of the 4th term, and December fees will still be payable. Payments are to reach the School’s account without any deductions on or before the **1st day of the month**. The latest date of payments will be the **3rd of the month**. If the school fees are not received by the **7th of each month**, learners will not be allowed to attend school until the fees are settled. Enrolment fees are not refundable. Payment of monthly school fees is not subject to presentation of a statement, although one will be given on request. Payments are made in accordance with the applicable fees at the school.

NB: Test fees should accompany the enrolment forms. The registration fee should be paid in thereafter with the school fees of the first month.

Breach of Contract

In the event where the undersigned responsible persons commit a breach of contract of any of the terms of this agreement, the School may in its sole discretion: 1. Refuse the student entry to the School’s premises until the breach has been remedied; or 2. Claim damages from the responsible persons; or 3. Take whatever legal steps that may be necessary. In the event of the School taking legal action against the responsible person, he will be liable for all legal fees on an attorney client scale, collection costs and commission, interest and tracing fees.

General

This Agreement constitutes the whole Agreement between the parties relating to the subject matter hereof. No amendment or consensual cancellation of this Agreement of any provision or term thereof or of any Agreement, bill of exchange or other document issued or executed pursuant to or in terms of this Agreement and no settlement or any disputes arising under this Agreement and no extension of time, waiver or relaxation or suspension of any of the provisions or terms of this Agreement or of any Agreement, bill of exchange or other document issued pursuant to or in terms of this Agreement shall be binding unless recorded in a written document signed by all the parties. Curriculum

Cancellation

The responsible persons undertake to give 30 calendar days written notice of termination of the enrolment of a student, applicable to term 1, 2 and 3, failing which the liability be incurred for the full amount of the following term’s fees. If such notice of termination be given in the 4th term of the year, the full terms’ fees, up to and including December, are payable.

STATEMENT OF FAITH

Accelerated Academy exists for the Christian discipleship and education of children through a Bible based curriculum. To excel in this endeavour, Christian unity within the school is a requirement. Therefore, families applying for admission must be likeminded regarding the practice and acceptance of the Accelerated Academy Statement of Faith outlined herein under. Please read the Statement of Faith closely to determine if it is in accordance with your family's personal beliefs and values.

1. We believe the Bible to be the inspired, infallible, authoritative, and inerrant Word of God (2 Timothy 3:16; 2 Peter 1:21).
2. We believe there is one God, eternally existent in three persons—Father, Son, and Holy Spirit (Genesis 1:1; Matthew 28:19; John 10:30).
3. We believe in the deity of Christ (John 10:33); His virgin birth (Isaiah 7:14; Matthew 1:23; Luke 1:35); His sinless life (Hebrews 4:15; 7:26), His miracles (John 2:11); His vicarious and atoning death (1 Corinthians 15:3; Ephesians 1:7; Hebrews 2:9); His Resurrection (John 11:25; 1 Corinthians 15:4); His Ascension to the right hand of God (Mark 16:19); His personal return in power and glory (Acts 1:11; Revelation 19:11).
4. We believe in the absolute necessity of regeneration by the Holy Spirit for salvation, because of the exceeding sinfulness of human nature; that men are justified by grace because of the shed blood of Christ; and that only by God's grace and through faith are we saved (John 3:16–19, 5:24, 25; Romans 3:23, 5:1, 8–9; Ephesians 1:3–5; 2:1, 8–10; Titus 3:5).

General Information

School Hours

Staff are at school from 07:00 each morning. School officially starts at 07:30 for Grade 1-12. Students should be at school before then to unpack their bags and for students in the Main Learning Centre to score any homework and get ready for Goal Check. Preschool students may be dropped off anytime between 07:00 and 08:00.

School closes at 13:00 for students in Grade RRR to Grade 1 everyday. School closes at 14:00 Monday to Thursday and 13:00 on a Friday for students in Grade 2 and up. There is supervision available till 14:00 for younger sibling who have to wait.

Aftercare facilities are available until 17:00 at an extra cost of **R500** per month. If collected after 17h00 we have a penalty of **R50** per day. There is a charge of **R50** if aftercare is arranged only for one afternoon.

School Holidays

School will be closed on Public Holidays and four prescribed holidays as set out in the school calendar at the beginning of each year.

Sick Policy and Medication

Sick children must be kept at home, especially if on antibiotics, for at least 48 hours, before the child may return to school. Children with a contagious disease should stay at home within the quarantine period, especially head lice, diarrhoea, mouth ulcers, chicken pox, mumps, measles, vomiting, fever, pinkeye, etc. We are not allowed to give any medication, without the parent's written consent. Should a child fall ill at school, parents will be contacted so that you can come and fetch them.

Progress Report

You will receive a Progress Report for your child each term. A time for parents to come in and meet with their child's teacher will be arranged during the 1st and 3rd terms. This time will be used to discuss your child's progress and view your child's work. Please support your child by attending.

Preschool Meals

Preschool students may bring their own lunch box or receive two meals during the day for an extra cost. A breakfast of porridge or oats will be served at 08:00. A cooked lunch will be served at 11:30. Preschool students should still bring an extra little healthy snack to eat during the day. The two meals prepared at school are at an extra cost of **R800 per month**.

Sport

All students participate in the PT program on a Thursday. PT uniform should be worn every Thursday. There is soccer and netball in Term 1 & 2 and hockey and cricket in Term 3 & 4. These sports are open for all students from Grade 1 and up. The Grade 1 students meet 13:00-13:45 and the students Grade 2 and up meet 13:45-14:30.

Other Activities

Students shall participate in other activities like indigenous games, chess, skipping etc on Wednesdays. The starting time for the games will be at 12h30 to 13h00 for Gr 1's and 13h45 – 14h30 for Grade 2 upwards. We encourage the mind games as well games that bring about social & physical development.

Outside Service Providers

A variety of outside service providers offer classes at an extra cost. These are completely voluntary, and payment is made directly to the service provider in question.

- **Build'em Brix – Offer an introduction to math and science through lessons designed to help listening skills and logical thinking for younger students.
From Gr RRR- Grade 1.**
- **Soccercise Starz – Offer soccer lessons.**
- **Robotix - A built up from Build them Brix. Students get to operate tablets and physically form structures which end up with movements.
From Grade 2 upwards.**
